Basic differences between a Copyright and a Trademark

A COPYRIGHT: Protects original creative works such as books, movies, songs, paintings, photographs, websites and choreography. As a copyright owner, you can control how your work is reproduced, distributed and presented publicly.

A TRADEMARK: Protects names, terms or symbols that are used to identify the products of a certain manufacturer or company. As a trademark owner, you can sue for trademark infringement in federal court and prevent others from importing foreign goods that display your trademark.
